- that I am aware of and accept all liability, fully exonerating Italian Exhibition Group Spa, for any damage, accident and any other damaging event to third parties in general/and or goods during the period in which the competition will take place, resulting from my improper use of the instruments, equipment and raw materials made available by Italian Exhibition Group Spa or due to faults and/or the improper use of instruments, equipment and raw materials provided by myself and/or failure to comply with hygiene regulations governing the provision, preparation and purveyance of foodstuffs;

b) In addition, I, the undersigned,

WHEREAS

- Legislative decree 196 of 30 June 2003 (personal data protection law) imposes on Italian Exhibition Group S.p.A., registered offices in Via Emilia 155, 47921 Rimini (Italy), in its capacity as personal data controller in accordance with the above decree, information requirements governing the processing of personal data using servers physically located in Italy; such personal data including photographic images and video recordings of natural persons and the texts of the verbal statements made to Italian Exhibition Group S.p.A., as well as authored and/or creative materials (e.g. finished products, creative designs, prototypes, slides and/or conference reports, etc.) and photographs of authored and/or creative material produced by the interested parties;
- articles 96 and 97 of Law 633 of 22 April 1941 governing “copyright and other rights connected with its application”, also impose on Italian Exhibition Group S.p.A. the obligation to obtain the prior written consent of the interested party to use the aforementioned personal data consisting of videos, photographs and/or interviews.

Italian Exhibition Group S.p.A. hereby declares, further to article 13 of Legislative Decree 196/2003 (personal data protection law) that, by means of its internal or external staff, Italian Exhibition Group S.p.A. shall collect and handle photographic images, videos and/or interviews involving participants in “The Pastry Queen” event and/or their authored and/or creative material, purely for information, advertising and promotional purposes; in particular, including but not limited to, by means of dissemination in information and/or illustrative brochures, newsletters, websites – such as, for example, www.iegexpo.it and its related websites - and social network profiles (non-comprehensive list provided by means of example).

Data may be processed by people appointed to do so by Italian Exhibition Group S.p.A., both internal and external to the company, electronically and/or in hard copy, and by means in line with the aforementioned purposes. Data handling is subject to strict security measures, in order to reduce to a minimum the risk of access by authorised personnel during the handling stages prior to publication.

Consent to the above data handling by participants to “The Pastry Queen” event is not compulsory, but a refusal to give consent will prevent Italian Exhibition Group S.p.A. from collecting and processing the aforementioned data for the aforementioned dissemination, advertising and promotional purposes, without prejudice to the fact that information not constituting "personal data" will in any case be freely available to use for statistical purposes.

Italian Exhibition Group S.p.A. may pass on the data to companies it has engaged to carry out market research, to advertising, communication and/or public relations companies, to companies engaged to print advertising or promotional materials, to website design companies, to web marketing companies, to other service providers engaged to design and/or maintain promotional materials, to professional firms, to photographers, to companies that carry out post-production editing of the audio-visual materials, to journalists and newspapers, to companies responsible for maintaining the IT systems on which the data is published and to possible third-party commercial partners with which Italian Exhibition Group S.p.A. shares the aforementioned promotional initiatives, which will handle them for the purposes described above.

Participants in “The Pastry Queen” event will have the right to exercise their rights over their data as provided for by article 7 of Legislative Decree 196/2003, including accessing their data and asking for confirmation of the existence of such data, and updating, amending or correcting them, and to refuse the handling of their data by the data controller at any time, for legitimate reasons.

c) Finally, I, the undersigned, hereby declare that I have read and understood the information provided for under the terms of article 13 of Legislative Decree 196/2003, reproduced herebelow:

In accordance with the provisions of article 13 of legislative Decree 196/2003 (personal data protection law), Italian Exhibition Group S.p.A. hereby confirms that the personal data provided by the participant to “The Pastry Queen” event, or otherwise acquired in the course of its business by Italian Exhibition Group S.p.A. shall be handled in accordance with the requirements of

confidentiality and in compliance with the specific provisions of the above law.

The processing of the above data, to be carried out using IT, manual or hard copy tools (e.g. the publication of photographs in brochures, etc.) is for the following purposes:

1. Compliance with contractual and legal obligations relating to the interested party's participation in "The Pastry Queen" event.
2. Profiling, loyalty building and the sending of commercial and promotional communications regarding the business of Italian Exhibition Group S.p.A. by email, text messaging, multimedia messaging, telefax, telephone calls, direct sales and other marketing purposes (e.g. market research and surveys).

By the handling of personal data, we mean the collection, registration, organisation, storage, processing, editing, selection, extraction, comparison and reclassification of data into similar financial or economic categories, and the use, linking, communication and dissemination of such data. The duration of the data handling period shall be proportionate to the purpose applicable to each case.

The provision of data to Italian Exhibition Group S.p.A. is always voluntary. However, in the event that – as is normally the case for those intending to participate in events organised by Italian Exhibition Group Spa - the data the provision of which is required is to be handled by Italian Exhibition Group S.p.A. for the purpose of correctly complying with a legal or contractual obligation, or for provision of the information of the interested party required (the purpose described in point 1), the provision of such data is in fact necessary. In fact, failure to provide their data by a person intending to take part in the "The Pastry Queen" event would inevitably render it impossible for Italian Exhibition Group S.p.A. to provide the contractual service required and/or to meet the legal obligations arising from the contractual relationship. Therefore, in practical terms, it would not be possible to take part in "The Pastry Queen" event. Consent to the handling of data for the purposes of point 1, on the other hand, is never necessary (as article 24 of Legislative Decree 196/2003 exempts Italian Exhibition Group S.p.A. from the obligation to request it).

Italian Exhibition Group S.p.A. hereby specifies that "provision" of data shall mean the material made available by the same to Italian Exhibition Group S.p.A., and therefore does not equate to "consent" to its handling for the purposes specified in point 2; it is presumed that interested parties providing their data (having read this information) tacitly consent for the sole reason that their data will be handled for the purposes described in point 1.

However, in the event that data handling takes place for the purposes described under point 2, consent is voluntary and the failure to give consent shall not result in non-provision of the service required by the interest party, but shall mean that Italian Exhibition Group S.p.A. will not be able to handle such data (for example, using an email address or mobile phone number for sending promotional messages).

Italian Exhibition Group S.p.A. also informs participants that article 7 of the above data protection law recognises several rights of the interested party, including those of: obtaining information about the existence of data concerning them and their communication in intelligible format, obtaining their deletion, conversion into anonymous format or blocking, or their updating,

amendment and, if required, their integration, as well as confirmation that such operations have been made known to those to whom the data has been provided, refusing the handling of such data for legitimate reasons, even if relevant for the purpose of their collection and refusing the handling of their data for marketing purposes (profiling, commercial communications and market research and surveys).
